(Art Show Rules, Continued)

4. Space will be assigned on a first-come, first-served basis. Please indicate if you prefer space in the Pavilion. Pavilion set up is Saturday, June 1, at 7 a.m.
5. Tent set up will be Friday, May 31st, from 7 a.m.-5 p.m. and Saturday June 1, from 7 a.m.-9 a.m. Times will be given for load-in and load-out. Those not complying will be asked to return at their designated time. Booth space is approximately 10'x10', while Pavilion space is 8'x8'. You must remain with your space. No staking of tents allowed. All placement of exhibitors will be made by Show Committee and is considered final.
6. Screens and tables must be covered with a neutral cover.
7. Electrical access is not provided. No generators allowed.
8. No refunds will be made if the show is not held due to reasons beyond the control of Aldridge Gardens.
9. Due to limited parking, ARTISTS MUST USE OFF-SITE PARKING AND SHUTTLE.

NON-COMPLIANCE WITH RULES MAY RESULT IN EXCLUSION FROM ART IN THE GARDEN.

AWARDS

Best In Show – \$500

Best In Category – \$150 each

Each exhibitor will submit one work to be judged. Only one award per exhibitor. No award if category does not have at least three participants.

Only original work is eligible for judging, and no prints except with photography. Paintings and photographs must be framed or matted.

Show committee artists are not eligible for prizes.

Judging will take place on Saturday, with ribbons being awarded immediately afterwards. Cash prizes will be awarded at the Artists Reception. Decision by the judges will be considered final.

THIS SHOW IS LIMITED TO ARTISTS WHO ARE RESIDENTS OF ALABAMA.

Please submit the following to enter:

- Check or money order for \$100 (\$75 booth fee and \$25 non-refundable jury fee). For double booths, pay \$175 (\$150 for two booths and \$25 non-refundable jury fee).
- Your application is a commitment to show. No refunds will be issued.

- Please submit three photos, CDs, or slides that best represent the work to be exhibited and sold. Also submit one photo, CD, or slide of your booth setup. Materials will not be returned.
- Include a stamped, self-addressed #10 envelope for notification of acceptance.
- The Selection Committee will choose exhibitors that best reflect creativity, quality, and originality. ABG reserves the right to exclude any work deemed inappropriate for the show. All decisions are final.
- Notification of artists will take place as soon as possible after April 1st.

- Include stamped, self-addressed envelope
- Submit late fee (If sent after March 29, 2013)
